

SNAP-QCS 380 Variable Length Format Upload Guide

Introduction

The original 380-1 upload file is a fixed 80 column text format file for state to upload active or negative cases to SNAP-QCS system. With the arrival of 380 form, the number of fields reach to 1000 level and the original 80 column format doesn't serve well. The solution is a free variable length xml format upload schema. The current user guide provides detailed description for the new format.

Variable Length Upload File Format

The new variable length upload file format is a combination of fixed and free format: the first and last rows of the upload file declare the case type and trailer respectively. In between are the cases information (single or multiple cases). For each case, its first row is always the review number, following with multiple fieldId and value pairs.

\$TRAIL	Identify this as the last row of the file						
\$fiscalYear	Must be 4 digits. Starts with \$ and begins right after \$TRAIL.						
\$stateFips	Must be 2 digits. State FIPS code starts with \$ and begins right after \$fiscalYear.						
\$stateName	State name can be full name or short name.						
\$reviewCount	The actual count of reviews in the file.						
\$rowCount	The count of the rows in the file, including header and trail rows.						

Remarks:

- a. One upload file can only contain reviews of one case type, one fiscal year and one state
- b. The upload file must have header row as the 1st row and 1 trail row at the end of the file
- c. All data rows must start with the 6 digit review number row
- d. The review data for one review can cross multiple rows
- e. Long text fields (all Narrative fields in 380 and Section V in 245) can be split into multiple field instances. The system will connect them all together.
- f. Every field instance contains a {fieldid} and field value. If there is no value, the fieldId is not required.
- g. If the field id is not defined in SNQP-QCS, or it has been retired, the field value will be ignored without generating an error.
- h. Fields can be in any order.
- i. A field's total length cannot exceed the max length defined in additional tabs found in this excel workbook
- j. Extended list must use the same rowIdx as the master list.
- k. Extended list is a list extended from master list. See below:

Extended list must use the same rowIdx as the master list. This ensures the same person in Extended List as in Master List, e.g: When Section B has 2 people with rowIdx 0, 1, the part from upload file will be like:
